3	Piping Spool hydrotesting Company to clarify on the requirement of TPI for witnessing Hydrotesting. Also Kindly advise when there is field joint to an existing Pipeline then whether company or Contractor will be responsible for the existing line & related equipment in case of any failure or damages to existing equipment.	* TPI is not required for witnessing the hydrotest of vessel and pipeline. Offshore platform - 2 KM from shore. Contractor has to travel through tug boat to offshore platform from Magdalla Jetty. 4 Ank Facility - 60 KM from Gas Plant

From Magdalla Jetty, Surat (Near Surat Airport). Refer to clause 11 on page 6 of "Additional information" section. Design capacity to accommodate 80 persons at platform.
21	Whether any cost is liable on contractor for accommodation & food of manpower at offshore location towards stay for work completion	Accommodation and Food while working at platform is in company's scope.
